

URGENT NEED TO RAISE \$250K TO OCCUPY BUILDING

Dear Devotees & Friends of Dhamma:

Thanks to the generous donations from our devotees, the major contribution of \$3.5 million from Mr. Roshan Wijerama and his family foundation, and a bank loan of \$1.3 Million, about 95% of the New Jersey Buddhist Vihara (NJBV) building project has been completed (see attached photos). These include connection of all utilities, HVAC, interior & exterior building finishes, installation of toilets, parking lot lighting, etc. The only major items remaining to obtain a Temporary Certificate of Occupancy (TCO) to start using the building are paving the road and constructing the sidewalks estimated at \$250,000.00.

To raise the \$250K, we embarked on a program in May 2025, titled "Help Us Pave the Way" for devotees to sponsor the construction of the parking lot at \$5/sf (with a minimum 20sf donation). As we want to complete the paving before winter, we are planning to accelerate and expand that program by requesting donors (as a group or individually) to sponsor each of the 76 parking spaces at \$2,500/space. We have listed a few options below and we would genuinely appreciate it if you could select one of the options and advise a Fundraising Committee member below, or Ven. Sirirathana.
